**SUBJECT:** Required Professional Learning for MCEA Members for Summer 2021

## Summary

The purpose of this memorandum is to provide information about 2021–2022 systemwide required Tier 1 teacher training for summer 2021.

- The **required** summer teacher training is accessible via the [professional learning webpage](#) or directly on the [required training grid](#).
- Principals will review this information and ensure that teachers are notified of their required training sessions.
- All Montgomery County Public Schools (MCPS) teachers are expected to review the attached information to determine which courses they are required to attend based on position and teaching responsibility and plan accordingly. Teachers are expected to complete the registration process and fully attend required training.
- When multiple sessions are offered, teachers choose one session and register through the Professional Development Online (PDO) system. Teachers may not attend parts of different sessions.
- **There are no “salary days” built into the 2021–2022 calendar.** As a result, teachers who are identified as needing to attend Tier 1 summer training (see [required training grid](#)) will be paid at their hourly rate.

## Background

Required professional learning is one of many components in our collaborative efforts to provide all educators with the knowledge and skills needed to deliver an effective instructional program and to provide all students with an equitable, rigorous, and supportive learning environment. This notification of professional learning and professional work days is in alignment with the MCPS and Montgomery County Education Association (MCEA) negotiated agreement stipulating a March 1 notification deadline. **All professional learning sessions are contingent on final approval of the MCPS Fiscal Year 2022 Operating Budget. Final decisions will be made and communicated to staff by June 1, 2021.**

## Important Dates

- Elementary teachers with required training, **except Pre-K literacy and elementary math** will begin registration at 5:00 p.m. on Wednesday, April 7, 2021.
- **Pre-K teachers with required training for literacy**; and **elementary teachers with required training for mathematics** will begin registration on Thursday, April 8, 2021.
- Registration for systemwide required Tier 1 training for summer 2021 for **elementary teachers** will begin at 5:00 p.m. on Wednesday, April 7, 2021.
- Registration for systemwide required Tier 1 training for summer 2021 for **secondary teachers** will begin at 5:00 p.m. on Thursday, April 8, 2021.

## Action Required

Teachers should register for applicable required summer training. If there is a reason that a teacher cannot attend summer training, principals need to report the alternative plan determined.

## Summer 2021 Professional Learning Overview

### Required Summer Training

In accordance with the Montgomery County Education Association (MCEA) negotiated agreement stipulating a March 1 notification deadline, the **required** Tier 1 summer teacher training events for this summer are accessible via the [professional learning webpage](#), or directly on the [required training grid](#). Recommendations for required training were provided through the professional learning recovery team that includes teachers across all levels. All Montgomery County Public Schools (MCPS) teachers are expected to review the attached information to determine which sessions they are required to attend based on position and teaching responsibility. Teachers are expected to complete the registration process and fully attend their summer training. Successful completion of summer training is an important component of Standard V of the Teacher Professional Growth System—*Teachers are committed to continuous improvement and professional development*. When multiple sessions are offered, teachers choose one session to attend. Teachers must attend an entire session and may not attend parts of different sessions. Full-day training is six hours.

### Compensation for Summer Training

This summer, due to approved school calendar and teacher work schedules, there are no “salary days” built into the calendar. As a result, for the summer of 2021–2022 school year, the training calendar looks different, and aligns to how MCPS previously conducted summer trainings. All staff members are expected to participate in compliance training (please see section below). Beyond that, as in the past, required training will only be for certain designated teachers, often but not limited to, those teachers implementing a new curriculum or resource. It is important to note that teachers will be paid at their current hourly rate of pay at the time of their participation in Tier 1 training. Only those teachers listed as required to attend will be paid for this summer training. All teachers will be paid for summer training no later than October 1, 2021.

### English Language Arts and Math Training for New Curriculum for Special Education Teachers

For funding purposes, special education teachers and general education teachers will register for required summer training in the new English Language Arts and mathematics curricula using separate Professional Development Online (PDO) course numbers. The PDO course numbers for special education teachers and general education teachers are included in the [required training grid](#). Please note that while the PDOs are separate, special education teachers will physically be in training sessions with all other staff who are participating in the training; special educators are not being separated in the actual training rooms.

### English for Speakers of Other Languages Training for WIDA

The WIDA English Language Development (ELD) Standards Framework has been updated and all English for Speakers of Other Languages (ESOL) teachers are required to attend summer training to learn about the new framework. Two-Way Immersion (TWI) general educators are strongly encouraged to attend this training as a Tier 2 opportunity. This framework provides a foundation for language instruction as connected to content and assessment for multilingual learners in K–12. For accountability purposes, elementary and secondary ESOL teachers and TWI general educators will register for summer training using separate PDO course numbers. Please note that while the PDOs are separate, K–5 ESOL teachers and TWI general educators will not be separated in the actual training rooms. Also, note that 6–12 ESOL teachers will not be separated in the training rooms. The PDO course numbers are included in the [required training grid](#).

### Make-up Opportunities for Summer Training and Alternative Plans

Teachers who are not able to attend required training due to extenuating circumstances, are expected to work with their principal to come up with an alternative plan for learning the information. For synchronous training sessions that are offered many times throughout the summer, teachers are expected to give every effort to attend a session. Every effort will be made to offer an asynchronous option so that upon return to duty, staff can meet the required training expectations. **Staff should reach out to the contact person identified on the required training grid to access the asynchronous training.**

### **Other Professional Learning—Secondary**

Please note that as communicated in the February 25, 2021 memorandum, *Dates for 2021–2022 Secondary Resource Teacher Week and Secondary School Leadership Team Week*, Secondary Resource Teacher Week will be held on selected dates by content areas during the week of July 5–9, 2021. Secondary School Leadership Team Week will be held July 12–16, 2021.

### **Staff with Required Summer Days**

Staff with summer employment (SE) days may be required to use some of those dates to attend training. Please see the specific expectations below:

- Elementary Staff Development Teachers (SDTs) and elementary media specialists are expected to use their SE days to attend their first two days of required training. If an elementary SDT or media specialist has more than two days of required training, the rest of the days will be paid using Tier 1 funds.
- Secondary Resource Teachers (RTs) or Content Specialists (CS) are expected to use their SE days to attend their first two days of required training. If a secondary RT or CS has more than two days of required training, the rest of the days will be paid using Tier 1 funds.

### **Other Summer Training Activities**

Other training will be offered this summer including training for school and system initiatives for teams of teachers (e.g., school-based crisis team training), training and courses for teacher certification and employment (e.g., Continuing Professional Development, safety training), as well as voluntary training. These summer training opportunities for teachers and other school staff members will be posted on PDO by the end of April 2021. Tier 2 training activities will be paid at a rate of \$20 per hour. Other trainings will be offered on a voluntary basis as no-pay opportunities.

### **New Educator Orientation**

Our annual New Educator Orientation (NEO) will be the week prior to Pre-Service Week for Teachers. All new teachers to the district are strongly encouraged to attend this induction and onboarding event. Teachers who attend NEO will receive Tier 2 stipend pay for those two days. New special education teachers and ESOL teachers are strongly encouraged to attend the third day of NEO. Special education teachers and ESOL teachers will receive an additional Tier 2 stipend pay for attending the third day of training. NEO will take place via a virtual platform.

### **Annual Districtwide Mandatory Compliance Training**

All MCPS employees are required to complete the 11-module districtwide mandatory compliance modules each year of employment. The mandatory training consists of 11 online modules designed to be completed asynchronously. Topics include: recognizing and reporting child abuse and neglect; equal opportunity in the workplace; bullying, harassment (including sexual harassment) and intimidation prevention; religious diversity; ethics; conflict of interest; student gender identity; and other important issues. Additionally, based on your MCPS position, you may be required to complete job-specific trainings that are separate and in addition to the districtwide compliance modules. Your principal or supervisor will notify you of these requirements. ### **Next Steps**

10-month employees should use the [required training grid](#), along with the [professional learning webpage](#), to identify any required training they will need to attend. PDO is able to handle 4,000 concurrent users. If users are experiencing difficulty, they should log out and come back later.

## Summary

The purpose of this memorandum is to provide information about the 2021–2022 systemwide Tier 1 and Tier 2 training opportunities that have been extended to Fall 2021. MCPS has made significant efforts to provide flexibility for MCEA and SEIU members to attend training in the Fall, or asynchronously to the extent possible; not all trainings offered over the summer will be offered this Fall.

- Teachers/Staff who take Tier 1 courses this Fall, before or after school, will be paid at their hourly rate of pay.
- Teachers/Staff who take Tier 2 courses this Fall, before or after school, will be compensated at \$20 per hour.
- Teachers who use substitutes to cover their classes while participating in training will not receive additional pay.
- Much of the technology training will remain asynchronous so that staff can access when convenient.
- A list of Professional Learning Opportunities that will be extended for the Fall is provided in the Attachment.
- Registration for systemwide training will be available on PDO on Monday, August 23, 2021, at 8:00 a.m.

Please share this memorandum and professional training information with all MCEA and SEIU staff at your worksite.

## Background

Required professional learning is one of the many components in our collaborative efforts to provide all staff with the knowledge and skills needed to deliver an effective instructional program, and to provide all students with an equitable, rigorous, and supportive learning environment.
