SCHOLARSHIP APPLICATION CRITERIA AND PROCEDURES

- 1. Must be a graduating African-American male who lives and attends a public or private school located in Montgomery County, Maryland.
- 2. Must utilize funds towards an accredited four (4) year institution of higher education in the United States during the upcoming academic year.
- 3. Must submit an official school transcript with your cumulative unweighted and weighted GPA. Transcript must include the first semester of the senior year. Transcripts must be submitted in a sealed envelope from the school registrar or electronically submitted by an authorized school official sent to "Scholarship@iul1906.org".
- 4. Must submit one (1) typed, dated, and signed letter of recommendation on official organization letterhead from a non-school related community service or job-related organization verifying your involvement.
- 5. Must submit one (1) typed, dated, and signed letter of recommendation from your current high school principal, counselor, advisor or teacher on the school's official letterhead. Recommender must specify the relationship or capacity in which they know or observed the applicant.
- 6. Must complete an essay not to exceed 1000 words.

Essay topic:

"Artificial Intelligence (AI) can be considered a help or hindrance in educating students for the future, do you agree or disagree with this statement; explain your rationale as to why or why not?"

or

How is Artificial intelligence (AI) impacting the political landscape in elections, and what are the potential benefits and risks associated with its use in campaign strategies and voter engagement?

- 7. Must submit a recent portrait size (5x7) color photograph with the applicant's name printed on the back of the photo. The photo must be a business, formal, or scholarly cap and gown. Proofs, cell phone, personality, or scanned photos are not acceptable.
- 8. Application MUST be signed by the student and parent or legal guardian.
- 9. Completed applications in the original format along with attachments, official transcript, photo, and recommendations will be received electronically at Scholarship@iul1906.org (no physical packages will be accepted).
- 10. Completed applications must be received by Friday, April 04, 2025. All information on this form is considered confidential. All materials, including the photo become the property of ASCF. Please direct all questions to the scholarship Committee Chair at SCHOLARSHIP@iul1906.org.
