### School Improvement Plan



All schools develop or revise a School Improvement Plan (SIP) each school year. During the summer and early fall, schools draft the SIP by examining data collected from student assessments and parent, staff, and student surveys. This data is used to determine where to focus efforts to enhance and improve instruction based on the needs of our students, staff, and families; to allocate resources; and to plan parent/family and staff training. Parents and families are an important and vital part of the SIP process, and are invited to participate so that their ideas and suggestions can be incorporated into the school's plan.

Your child's school will post a snapshot of the Title I SIP on their website for your review. The snapshot includes school improvement goals, as well as information about the academic and non-academic areas of focus, and family engagement. If you would like to participate as a member of the SIP planning team, request a copy of the school's SIP plan, or make comments about the plan, please contact your school's principal.

### **Right to Request Information**

Our school is fortunate to receive supplemental funding through Title I, a federal grant program for schools that serves communities with students who have high economic needs. The federal legislation that establishes Title I regulations is known as the Every Student Succeeds Act of 2015 or ESSA for short which replaces the No Child Left Behind legislation. ESSA requires the Montgomery County Public Schools to inform you that you have the right to request information about the professional certification qualifications of your child's teacher, substitute teacher, or paraeducator.

If you wish to request certification information about your child's teacher, paraeducator, or long-term substitute teacher, please submit a written request to the principal at your school. Your written request may include information about the following qualifications:

- Degree status and subject area of certification
- State of Maryland certification status, including conditional certification status
- Qualifications of paraeducators or long-term substitute teachers who may be working with your student

Your request will be forwarded to the Office of Human Resources, and you will receive a written response from them within 30 business days.

#### Our Process

- ★ The plan provides information as to how the Title I requirements will be carried out at the district level.
- ★ Family workshops, parent meetings, and other events are opportunities for families to provide feedback using the Evaluation Tool.
- ★ The feedback from the Evaluation Tool is analyzed annually at the Spring FAC meeting. Suggestions are provided to revise the plan and create opportunities for increased family engagement.
- ★ A school-level template that includes the same requirements is used to create a School-Level Parent and Family Engagement Plan at each Title I school.
- ★ Schools analyze and make revisions to their School-Level Parent and Family Engagement Plan at each Title I school annually at their Family Engagement committee meetings and leadership meetings.
- ★ The School-Level Plan is distributed to families each fall in a variety of ways including newsletters, electronic communication, and family meetings/workshops.

# MCPS Title I Believes in Supporting Families by Building Capacity through Training and Professional Learning

## Build Capacity through Family Activities

**Parent Academy:** The MCPS Parent Academy provides workshops and training to parents and families at least twice a month during the school year, at various times and locations, on a variety of topics such as:

- ★ understanding the State academic standards, State and local academic assessments, and how to monitor a child's progress;
- ★ supporting the development of their child's physical, social, and psychological well-being;
- ★ working with educators to improve student achievement; and helping parents work with their children.

**Family Workshops:** Title I instructional specialists provide materials and training to parents/families and school staff members at each school on:

- ★ understanding Title I requirements
- ★ enhancing communication, collaboration and outreach between home and school
- ★ supporting their children's academic progress at home

**School Parent/Family Engagement Processes:** Title I Instructional specialists support schools and families by:

- ★ providing resources and training to teachers in Title I schools on best practices for having effective communication, collaboration and engagement with families.
- ★ providing resources and training for families to engage in successful parent-teacher partnerships
- ★ working with Family Engagement Committees in their quarterly meetings to ensure that parents/families have the opportunity to collaborate and make decisions about how family involvement funds are spent.

## Build Capacity through Staff Training

**Staff Training:** Technical assistance is provided throughout the year by Title I Instructional Specialists through a variety of forums and on an array of topics related to their work as members of central office staff and school-based staff members. Support provided to schools includes but is not limited to:

- ★ Developing school-parent/family compact and school-level Family and Parent Engagement Plan
- ★ Planning and developing professional learning for school staff members to work as equal partners and collaborators with parents/families
- ★ Communicating and collaborating with families as equal partners in their children's education
- ★ Providing training with the Family Engagement Specialist to school-level Parent Community Coordinators.
- ★ Connecting school-level Parent Community Coordinators with resources and community-based organizations to increase parent and family engagement.

**Instructional Specialist Training:** Title I instructional specialists communicate, coordinate, and collaborate to ensure compliance of federal and state requirements. Title I staff members also will receive training on relevant issues which they will share with school staff members and families, including but not limited to:

- ★ Evidence-based strategies for parent and family engagement
- ★ Preparation, training, and monitoring of family involvement budgets
- ★ Coordinating collaboration of parents/families in family involvement budget decisions
- ★ Appropriate use of federal funds for family engagement initiatives and efforts by Title I schools

## Support to Schools

The Division of Early Childhood and Title I Programs, and Recovery Funds (DECTIRF) communicates, coordinates, and collaborates in family engagement initiatives with MCPS offices by:
