Student Service Learning Graduation Requirement

Middle school and high school students may continue earning SSL hours towards their SSL graduation requirement by engaging in SSL opportunities during the summer, including traditional in-person opportunities and select virtual/remote opportunities that follow the temporarily amended guidelines posted on the MCPS SSL webpage (www.mcps-ssl.org). Current fifth-grade students may begin participating in SSL opportunities starting on June 17, 2021.

<p><u>Message to Share with Nonprofit Organizations (only if they contact you directly)</u></p>	<p>To meet the service-learning needs of our students during this time period, we are excited to announce that students can earn SSL hours for select remote/virtual service activities completed from home under the supervision of an approved nonprofit organization. These virtual/remote SSL opportunities may be offered to our students <u>through the summer of 2021 and until the end of the 2021-2022 School Year</u>. Nonprofit-hosted virtual/remote MCPS SSL opportunities must be posted on the Montgomery County Volunteer Center website (www.montgomeryserves.org) and tagged by the MCPS SSL office with the blue MCPS SSL banner and graduation cap icon.</p> <p>Students may also continue to earn SSL hours for traditional in-person MCPS SSL opportunities offered by a nonprofit organization in a public space under the direct supervision of a nonprofit representative, at the discretion of the student's parent/guardian.</p> <p>If your organization wishes to offer a remote/virtual SSL opportunity to students, <u>please carefully review the temporarily amended MCPS SSL guidelines</u> (https://bit.ly/VirtualSSLGuidelines) that have been created to ensure that any virtual/remote service during this time maintains the safety and privacy of our students and adheres to the proper supervision and monitoring needed for SSL as a state graduation requirement.
